

Deductible "Other than Cash Contributions"

How much can you deduct for the used goods you gave to charity last? The IRS allows you to deduct the fair market value of an item...that is, the price it would sell for in a thrift-shop The quality of the item when new, as well as its age and present condition, must be taken into account, and may make the item worth more or less. Here is an up to date list of what various items are selling for at the Salvation Army and Goodwill. To determine the value of items not on this list the Salvation Army suggests taking 25% to 30% of the item's selling prices as its fair market value.
